

- G. S. R. ___(E).—In exercise of the powers conferred by proviso to article 309 of the Constitution and in supersession of the Regional Implementation Offices of the Department of Official Language, (Group 'C' Posts) Recruitment Rules, 2016 except as respect things done or omitted to be done before such supersession, the President hereby makes the following rules, regulating the method of recruitment to the post of Upper Division Clerks, Lower Division Clerks, Stenographer Grade 'D' and Multi Tasking Staff in the Regional Implementation Offices of the Department of Official Language, Ministry of Home Affairs, namely;-
- 1. Short title and commencement.—(1) These rules may be called the Regional Implementation Offices of the Department of Official Language, (Group 'C' Posts) Recruitment Rules, 2024.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of posts, classification and Level in the pay matrix.—The number of the said posts, their classification and the Pay Band and Grade Pay or scale of pay attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. Method of recruitment, age limit, qualifications etc.—The method of recruitment, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.
- 4. Disqualification.—No person;
 - (i) Who has entered into or contracted a marriage with a person having a spouse living, or
- (ii) Who, having a spouse living, has entered into or contracted a marriage with a person, shall be eligible for appointment to the said posts.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so, doing, exempt any person from the operation of the rule.

- 5. **Power to relax.**—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.—Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, Scheduled Tribes, other Backward

Classes, Ex-serviceman and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

promotion, their senior would also be considered provided they are not short of the requisite qualifying service by more than half of such qualifying or eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service.

Note 1: For the purpose of computing minimum qualifying service promotion, the service rendered on a regular basis by an officer prior to 1st January,2006 or the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended shall be deemed to be service rendered in the corresponding pay or pay scale extended based on the recommendations of the Pay Commission.

Deputation/absorption:

Officers of the Central Government

- (a) Holding analogous post on regular basis; or
- (b) With eight years regular service in the grade of Lower Division Clerk or equivalent

Note 1: The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation

Similarly the deputationists shall not be eligible for consideration for appointments by promotion.

Note 2: Period of deputation including the period of deputation in another ex-Cadre post held immediately preceding this appointment in the same or some other

organization or department of the Central Government shall ordinarily not exceed three years.

The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.

Note 3: For the purpose of appointment on deputation or absorption basis the service rendered on a regular basis by an officer prior to 1st January, 2006 (the date from which the revised pay structure based on the Sixth Central Pay Commission recommendation has been extended) shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre revised scale of pay into one grade pay or Pay Scale and where this benefit will extend only for the post or posts for which the grade pay or pay scale is the normal replacement grade without any upgradation.

Note 4: All officers on appointment to the grade whether by promotion, deputation or absorption shall be required to undergo suitable training as may be specified by the competent authority.
