Subject: 'Rajbhasha Gaurav Puraskar Yojna 2016' for writing original book in Hindi.

Books published during 01.05.2016 to 31.12.2016 are invited for the following award schemes of Official Language Department, Ministry of Home Affairs for original book writing in Hindi.

1. Rajbhasha Gaurav Puraskar for Central Government Employees (including retired employees) for writing original book in Hindi.

Eligibility/Conditions:

- (i) The author must be a working/retired officer/employee of the Ministries/Departments/Attached/Subordinate offices of the central government, Public Sector Undertakings, Nationalised Banks/Financial Institutions and Autonomous Bodies, Central Universities/Training Institutes owned or controlled by the central government.
- (ii) Author should send his/her entry with the attestation and recommendations of the Head of Department/previous department.(form-1)

Awards:

Following prizes will be awarded in this scheme -

First Prize - Rs. 1,00,000/- (One lakh rupees) A certificate

and a Memento

Second Prize - Rs. 75,000/- (Seventy five thousand rupees) A

certificate and a Memento

Third Prize - Rs. 60,000/- (Sixty thousand rupees) A certificate

and a Memento

Consolation - Rs. 30,000/- (Thirty thousand rupees) A

2. Rajbhasha Gaurav Puraskar Scheme for Citizens of India for writing original book in Hindi on knowledge and science based subjects.

Subject: The book may be on various streams of modern technology/Science or contemporary subjects, for example:

- (i) Engineering, Electronics, Computer Science, Physics, Biology, Energy, Space Science, Medicine, Chemistry, Information Technology Management, Psychology etc.
- (ii) Contemporary subjects such as Liberalisation, Globalisation, Consumerism, Human Rights, and Pollution etc.

Eligibility: Any citizen of India can participate in this award scheme (Form-2)

Awards:

First Prize(One) - Rs. 2,00,000/- (Two lakh rupees) A certificate and

a Memento

Second Prize (One) - Rs. 1,25,000/- (One lakh twenty five thousand

rupees) A certificate and a Memento

Third Prize (One) - Rs. 75,000/- (Seventy five thousand rupees) A

certificate and a Memento

- 3. General Conditions for both the above mentioned schemes:
- (i) Entry can be sent for only one of the above mentioned schemes. In case of author, being more than one, each co-author must fill the proforma separately.
- (ii) Under the scheme only those books, which are original work of the author in Hindi, are accepted. Translated books are not accepted.
 - (iii) Books, which have been awarded previously by any government organisation will not be eligible. The author of the book must inform Department of Official Language immediately if the book has been awarded under any other award scheme before the declaration of the awards under the above mentioned schemes.
 - (iv) Under the scheme, books published during 01.01.2016 to 31.12. 2016 will be accepted.
 - (v) The book should be analytical and reviewing about the subject. Books written in the form of thesis for Ph.D., poems, novel, story, play etc. or text books will not be eligible.
 - (vi) The author will be responsible for facts and figures given in the book and must give references as proof, wherever it is possible.
 - (vii) If a person has received a prize under any scheme of Department of Official Language during the preceding three years, his/her entry shall not be considered. However, a co-author, (if any) can participate in the scheme. The co-author will be given the amount proportionally.
 - (viii) The books should have at least 150 pages.
 - (ix) If the Evaluation Committee arrives at a conclusion that none of the books, sent as entries, is suitable for the award, the committees' decision in this regard will be considered as final.
 - (x) In case, a book selected for the award has more than one author, award money will be divided equally among them.
 - (xi) International Standard Book Number (ISBM).
- 4. Procedure for sending the entries:

(i) The entry should be sent along with the proforma (essentially completed) given in Annexure, otherwise the same would not be accepted.

Government, bestows two awards each in all linguistic regions i.e. region A / B / C

under the 'Rajbhasha Kirti Puraskar Scheme' for the in-house journals in Hindi

published by the above organizations.

3. Awards are presented in the form of shields and certificates. Cash award is not

given under this scheme.

- 4. The minimum eligibility for this award scheme is as follows:
 - a) There should be at least 40 pages in the journal.
 - **b)** The number of pages in Hindi should be at least 80% of the total printed pages.
 - c) At least 2 editions of the journal should have been published during the period from 1st April to 31st March 2017.

5. Standards of evaluation method:

This year evaluation of these magazines will be done for maximum of 130 points. The details of these points are as follows.

According to the policy of the central government the use of official language Hindi in official work is to be increased by motivation, encouragement and goodwill. Prizes are given on the occasion of Hindi Day celebration under the main schemes of the department. With the purpose for promoting the official language Hindi, in compliance with the R esolution No. 11034/48/2014,O.L.(Policy),dated 25 March, 2015 and the amendment issued from time to time, Rajbhasha Gaurav Puraskar is being run for the writers of excellent articles published in the journals by officers/employees of the Central Government.

Purpose of scheme:

Periodical Hindi magazines are being published for the greater dissemination of official languages Hindi by the Ministries / Departments of the Central Government / Undertakings / Banks etc. Awards are given to the authors of excellent articles published in the journals by the central government employees so that the people who write articles in the official language can be encouraged and readers could get good articles in the magazines.

3. Eligibility to participate in the Rajbhasha Gaurav Award Scheme:

- (A) Working or retired personnel of the Central Government.
- (B) The article should has been published in the journals-magazines of any government organization during financial year 2016-17 (from April 1, 2016 to March 31, 2017).
- (C) Hindi speaking writer are those officials/employees whose declared residence is located in 'A' or 'B' Region.
- (D) Non-Hindi speaking writer are those officials/employees whose declared residence is located in 'C' Region.

1. Terms and Conditions

- (A) Maximum two articles of a writer will be accepted in this award scheme. In case of submission of more than two articles from a writer, first two articles received in the department will be considered. Other articles will automatically be null and void.
- (B) Original magazine is to be submitted with photo copy of the article. Otherwise, Article will not be included in the award scheme.
- (C) The author will be required to give the certificate of the originality of the article with the article.
- (D) It is necessary to submit the relevant papers in relation to retired personnel.

2. Prize

The following cash prizes along with mementos and certificates will be provided to the Award winning officials / employees.

Hindi Speaking

First Prize - Rs. 20,000/-Second Prize - Rs. 18,000/-Third Prize - Rs. 15,000/-

Non-Hindi speaking

First Prize - Rs. 25,000/-Second Prize - Rs. 22,000/-Third Prize - Rs. 20,000/-

3. Evaluation process

Each Ministry/Department will select two articles at their level. Ministry/ Department will send these Articles with details to the Official Language Department in the form given at Annexure 'A'. The Department of Official Language will evaluate these articles received from Ministries by the Evaluation Committee and select them for three prizes - first, second and third, each for Hindi speaking and Non Hindi speaking officials.

4. The appropriate entries about the winner of the award will be made by the concerned Ministry/ Department/ Office in the Service Book of concerned officer/employee.

- 5. Ministries / Departments are requested that out of the articles published in the financial year 2016-17, those selected through the evaluation process for selection as given in paragraph 6, must reach the Official Language Department by May 15, 2017 in sealed envelope on which "Rajbhasha Gaurav Puraskar Yojna 2016 for the Authors of Excellent Articles 2016-17" should be written.
- 6. All Ministries/ Departments are requested to circulate this scheme extensively among their officials/ employees as well as all the attached and subordinate offices.
