RESOLUTION

No.11034/01/2023-O.L.(Policy): A revised award scheme named 'Rajbhasha Gaurav Puraskar Yojna' from the year 2022-23 is introduced by the Department of Official Language, with an objective to encourage writing books originally in Hindi and to promote Official Language, in supersession of earlier Resolution No. 11034/01/2023-O.L.(Policy) dated 21.03.2023. Under the scheme, the citizens of India will be awarded as follows:-

- (A) Rajbhasha Gaurav Puraskar for writing original book in Hindi on knowledge and science based subjects.
- (B) Rajbhasha Gaurav Puraskar for writing original book in Hindi on Forensic Science, Police, Criminology Research and Police Administration.
- (C) Rajbhasha Gaurav Puraskar for writing original book in Hindi on subjects related to Culture, Religion, Arts and Heritage.
 - (D) Rajbhasha Gaurav Puraskar for writing original book in Hindi in the field of law.
- 2. Name: The name of the scheme shall be "Rajbhasha Gaurav Puraskar Scheme for writing original book in Hindi."
- 3. Definitions: In this scheme, unless the context otherwise requires:-
 - (i) "Scheme" means "The award scheme of Department of Official Language for encouraging writing original book in Hindi on subjects related to Technology, Science, Forensic Science, Police, Criminology Research, Police Administration, Culture, Religion, Arts, Heritage etc. and in the field of law."
 - (ii) "Original" means "It should be originally written in Hindi and published for the first time.

 Translation of books published earlier will not be included under the scheme.
 - (iii) "Book" means "published books".
 - (iv) "Year" means (a)Scheme year Financial year (b) Publication year Calendar Year

4. Objectives:

(A) Various Ministries/Departments/Offices/Undertakings/Banks etc. of the Central Government also deal with technical subjects in their official work. Difficulty is being faced to increase the use of Hindi in official work due to scarcity of books in Hindi on the subjects based on technology, science, forensic science, police, criminology research, police administration, culture, religion, arts, heritage and in the field of law. In addition, employees do face difficulties in doing their official work in Hindi as they are less-acquainted or non-aquainted with Hindi terminologies of these subjects. The Department of Official Language is undertaking this scheme with the sole objective to encourage writing books in Hindi on the above-mentioned subjects.

(B) Various Ministries/Departments have undertaken different award schemes related to Hindi at national level. Department of Official Language has been made sole Nodal Department for book scheme related to Hindi. Hence, relevant schemes among the award schemes related to Hindi being run by various Ministries/Departments at national level have been incorporated under the scheme. It has been decided to discontinue the other award schemes. If any Ministry/Department, in future, wishes to undertake any other award scheme related to Hindi it shall mandatorily consult with Department of Official Language before taking up any such scheme to avoid repetition of award scheme.

6. Eligibility:

- (i) The author/ co-author should be a citizen of India.
- (ii) The book should be be written on the genres mentioned as follows:-
 - (a) Engineering, Electronics, Computer Science, Physics, Biology, Energy, Space Science, Medicine, Chemistry, Information Technology, Management, Psychology etc; Contemporary subjects such as Liberalisation, Globalisation, Consumerism, Human Rights and Pollution etc.
 - (b) Forensic Science, Police, Criminology Research and Police Administration etc.
 - (c) Culture, Religion, Arts and Heritage etc.
 - (d) Subject related to Law

7. General Conditions:

- (i) In case of Author being more than one, each co-author must fill the proforma separately.
- (ii) Under the scheme only those books which are original work of the author in Hindi, are accepted. Translated books are not accepted.
- (iii) Books awarded previously by any government organisation will not become eligible. The author of the book must inform Department of Official Language immediately if the book is awarded under any other award scheme before the declaration of the awards under the above mentioned schemes.
- (iv) Under the scheme, books published during 1st January to 31st December are acceptable.
- (v) The book should be an analytical review of the subject it deals with. Books written in the form of thesis for Ph.D., poems, novel, story, play etc. or text books will not be eligible under the scheme.
- (vi) The author/co-author will be responsible for facts and figures given in the book and must give references wherever possible as proof.
- (vii) If a person has received a prize under any scheme of Department of Official Language during the preceding three years, his/her entry shall not be considered. However, a co-author, (if any) can participate in the scheme. The co-author will be given the amount proportionately.
- (viii) The books should contain at least 100 pages.
- (ix) If the Evaluation Committee arrives at a conclusion that none of the books, received as entries, is suitable for the award, decision of the committee in this regard will be considered as final.
- (x) In case the book selected for the award has more than one author the award money will be divided equally among them.
- (xi) Only books with ISBN will be accepted under the scheme.

8. Procedure for sending the entries:

- (i) The entry should be sent along with the proforma given at Annexure; otherwise the same would not be accepted.
- (ii) Kindly send three copies of the book invariably with each entry. The copies will not be returned.
- (iii) Entry filled in prescribed proforma must reach the Department before the last date so declared.
- (iv) An author may send only one entry under the scheme.

9. Evaluation procedure of Books:

Books will be evaluated by a committee constituted by Department of Official Language based on the criteria set by Department of Official Language. Joint Secretary, Department of Official Language will be the Chairperson of the committee. If necessary, Committee may include non-official renowned scholars/experts along with official members. The Committee will comprise of the following:-

- (i) Next of kin of the authors, who are sending their entries, will not be included in the Evaluation Committee.
- (ii) An official from the Ministry/Department concerned with the subject may be included in the Evaluation Committee for evaluation of the entries.
- (iii) The Evaluation Committee shall have the right to take advice from specialists/experts of the subject before deciding on a book.
- (iv) The evaluation committee will determine the assessment criteria themselves.
- (v) In the absence of consensus about the award the decision will be made by majority. In case for and against votes are equal on any decision, then the Chairperson shall have the right to vote to arrive at a decision.
- (vi) The official members of the Evaluation Committee will get TA/DA from the source, from where they get their salaries. The non-governmental members will be entitled to travelling allowance and daily allowance as per instructions issued by the Government from time to time and applicable during the period.
- (vii) The experts of the Evaluation Committee will also be entitled to honorarium as determined by the Department of Official Language.
- (viii) The Department of Official Language will take decision on recommendations made by the Evaluation Committee.

10. Declaration and distribution of awards:

- (i) Decision regarding the award will be intimated through a letter/email to all the awardees and placed on the website of Department of Official Language also.
- (ii) Distribution of the Awards will be held on the date fixed by the Department of Official Language.

11. General information:

- (i) Copyright on the award winning book will remain with the Authors/Publishers.
- (ii) Awardees coming from places other than the place fixed for distribution of award will be given to and fro fare for 2nd AC and daily allowance as per rules of the Government of India. Arrangement for lodging will be made by him/her at his/her own expenses.
- (iii) No correspondence regarding conferment of the award or procedure for selection of a book for the award will be entertained.

12. Right to relax the scheme:

If it is necessary or expedient in the opinion of the Central Government to do so, documenting the reason for it, any of the provisions of these regulations may be relaxed by issuing an order.

ORDER

IT IS HEREBY ORDERED that a copy of this resolution should be communicated to the all Ministries/Departments, President's Secretariat, Prime Minister's Office, Cabinet Secretariat, NITI Aayog, The Comptroller and Auditor General of India, Lok Sabha Secretariat, Rajya Sabha Secretariat, Secretariat of all the State Governments and UT Administrations.
